## ELIGIBILITY & APPLICATION REQUIREMENTS

1. You, an individual, must be at least age 18, and a member of the Brokaw Credit Union with an open primary share account and checking account to be eligible to obtain a VISA DEBIT card.
2. An application must be completed and approved.
3. No VISA DEBIT card will be issued in the name of an applicant whose signature does not appear on the application.
4. By signing the application you understand and agree that any person to whom you give the card may access each of your accounts identified on your VISA DEBIT card application.
5. By signing the application you understand and agree to comply with all Brokaw Credit Union rules and VISA DEBIT card rules.
6. Brokaw CU has the right to pull your VISA DEBIT Card because it has been lost, stolen or because of excessive overdrafts.
7. No stop payments are allowed on VISA DEBIT card transactions.

## ACCOUNTS YOU MAY ACCESS

1. Your checking account under your member number or,
2. Your primary savings account and one checking account under your member number.

## CARD ISSUANCE

1. We will mail your VISA DEBIT card(s) to your residence usually within 10 days after your application has been approved.
2. You will select your Personal Identification Number (PIN) at the time you activate your card.
3. VISA DEBIT cards may be issued as single or joint according to the signatures on your signature cards.

## TRANSACTIONS YOU MAY PERFORM

1. You may receive cash withdrawals from your account(s).
2. You may make transfers between your accounts.
3. You may receive information about your account balance(s).
4. You may make purchases and take cash advances anywhere VISA is accepted.
5. See applicable "Fees".

## RESTRICTIONS AND LIMITATIONS

1. Daily limit of 6 PIN based withdrawals, including ATMs, not to exceed \$300.00 for the day.
2. Daily limit of 20 VISA transactions, not to exceed \$2,000.00 for the day.
3. There is a monthly limit of 6 electronic withdrawals from savings.
4. If you enter 3 wrong PINs, your VISA DEBIT card will be taken by the ATM or merchant.
5. If you have 5 rejected transactions, your card will be taken by the ATM or merchant.
6. If you inform us of a lost or stolen card, the ATM or merchant will take your card.
7. Your card will be taken, as determined by us, if you misuse or abuse your VISA DEBIT card.
8. For security reasons, there are limits on the number of transfers you can make by ATM and check card.

## FEES

1. \$10.00 replacement card fee.
2. When you use an ATM not owned by us, you may be charged a fee by the ATM operator or any network used.
